He especially provides a line of communication for foreign clients from any country into the Indonesian legal system, building on a background in construction and industrial relations law, and facilitates advice and assistance. He also advises Indonesian clients.</p> <p>Peter practices in the commercial and corporate areas, especially in matters involving foreign investment.
